16 **BE IT ORDAINED** that the following millages are hereby levied on the

26 **BE IT FURTHER ORDAINED** that the proper administrative officials of
27 the Parish of St. Tammany, State of Louisiana, be and they are hereby empowered,
28 authorized, and directed to spread said taxes, as hereinabove set forth, upon the
29 assessment roll of the City of Covington for the year 2015, and to make the
30 collection of the taxes imposed for and on behalf of the taxing authority, according
31 to law, and that the taxes herein levied shall become a permanent lien and privilege
32 on all property subject to taxation as herein set forth, and collection thereof shall be
33 enforceable in the manner provided by law.

34 **WHEREUPON**, this ordinance having been submitted in writing, having
35 been read by title and adopted at a public meeting of the City Council of the City

1 of Covington, State of Louisiana, at which meeting a quorum was present and
2 voting, was then submitted to an official vote as a whole, the vote thereon being as
3 follows:


