NEEDED FOR PUBLIC PURPOSES**

15       **WHEREAS**, certain Christmas decorations as set out on Exhibit A attached  
16 hereto, are no longer used or needed for public purposes by the City of Covington;  
17 and

18       **WHEREAS**, these Christmas decorations, specifically two (2) Street Line  
19 Christmas Wreaths and thirty-two (32) Street Pole Christmas Wreaths, should be  
20 declared as not needed for public purposes; and

21       **WHEREAS**, a minimum price for said items, namely the Street Line  
22 Christmas Wreaths and Street Pole Christmas Wreaths, should be set at the  
23 minimum amount of One Hundred Six and No/100 (\$106.00) Dollars; and

24       **WHEREAS**, the Village of Folsom, Louisiana, has offered One Hundred  
25 Six and No/100 (\$106.00) Dollars for the said Christmas decorations, namely the  
26 Street Line Christmas Wreaths and Street Pole Christmas Wreaths; and

27       **WHEREAS**, the Covington City Council deems the sale of these items to  
28 the Village of Folsom, Louisiana, to be in the best interest of the City and its  
29 citizens; and

30       **WHEREAS**, notice of said sale of the items has been advertised in the  
31 City's official journal for the required time period as per Louisiana Revised Statute  
32 §33:4712, and

33       **WHEREAS**, the City Council has held its public hearing in accordance with  
34 law,

35       **NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City  
36 of Covington, at its regular session convened, that the said Christmas decorations,  
37 namely two (2) Street Line Christmas Wreaths and thirty-two (32) Street Pole  
38 Christmas Wreaths, be hereby declared as not needed for public purposes; and
