**AN ORDINANCE OF THE CITY OF COVINGTON
SETTING THE COMPENSATION FOR THE
MAYOR OF THE CITY OF COVINGTON FOR 2016**

14 **WHEREAS**, the Covington Home Rule Charter, Section 3-08, provides that
15 the compensation for the Mayor for the City of Covington for the year ending
16 December 31, 2016, be established at the time of the adoption of the 2016
17 Operating Budget; and

18 **WHEREAS**, the City Council of the City of Covington has adopted the
19 Operating Budget for the City of Covington for the year ending December 31,
20 2016.

21 **NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City
22 of Covington, in regular session convened, that the compensation of the Mayor of
23 the City of Covington under the Home Rule Charter for the year ending December
24 31, 2016, shall be set as follows:

- 25 1) Annual salary of \$84,609 representing a 5% cost of living increase
26 over the 2015 rate of compensation;
27 2) City-sponsored health insurance with the same contribution to
28 employee and dependent premiums as is afforded other full-time City
29 employees;
30 3) Life insurance with a \$50,000 benefit, the premium being paid by the
31 City, as is done for other full-time employees;
32 4) Long-term disability insurance, the premium being paid by the City,
33 as is done for other full-time City employees;
34 5) Benefit provisions of the Federal Insurance Contributions Act (FICA)
35 to be collected as payroll taxes/contributions to the social insurance
36 system (Social Security) in lieu of retirement benefits; the Mayor does
37 not participate in the Municipal Employees Retirement System
38 (MERS) as other eligible municipal employees;
