9 **AUTHORIZING THE MAYOR TO EXECUTE ALL LEGAL**
10 **DOCUMENTS NECESSARY TO ACCEPT A DONATION OF**
11 **IMMOVABLE PROPERTY, SAID IMMOVABLE PROPERTY**
12 **BEING LOCATED IN SQUARE 2010, DIVISION OF NEW**
13 **COVINGTON, CITY OF COVINGTON, ST. TAMMANY**
14 **PARISH, LOUISIANA, WHICH SQUARE IS BOUNDED BY**
15 **WEST 21ST AVENUE, SOUTH FILMORE STREET, WEST 20TH**
16 **AVENUE AND SOUTH PIERCE STREET**

20 **WHEREAS**, it is in the best interest of the citizens of Covington for the
21 City to accept the attached donation of immovable property; and

22 **WHEREAS**, acquisition of immovable property by the City requires an
23 Ordinance by the City Council; and

24 **WHEREAS**, the Mayor of the City of Covington is the proper party to sign
25 on behalf of the City, once authorized by the Council; and

26 **WHEREAS**, the City Council has held its public hearing in accordance with
27 law,

28 **NOW THEREFORE, BE IT ORDAINED**, by the City Council of the City
29 of Covington, at its regular session convened:

30 That the Mayor of Covington be and is hereby authorized to execute all legal
31 documents necessary to accept the donation on behalf of the City of immovable
32 property described as Lot 10 and the North 15 feet of Lot 9, Square 2010, and Lot
33 1 and the North 15 feet of Lot 2, Square 2010, Division of New Covington, City of
34 Covington, St. Tammany Parish, Louisiana, which square is bounded by West 21st
35 Avenue, South Filmore Street, West 20th Avenue and South Pierce Street.


1 BE IT FURTHER ORDAINED that if any provision of this ordinance shall
2 be held to be invalid, such invalidity shall not affect other provisions herein that
3 can be given effect without the invalid provision and to this end the provisions of
4 this ordinance are hereby declared to be severable.

5 This ordinance having been submitted in writing, having been read by title
6 and adopted at a public meeting of the City Council of the City of Covington, State
7 of Louisiana, was then submitted to an official vote as a whole, the vote thereon
8 being as follows.
