11 **WHEREAS**, each year the City of Covington is required by our DEQ
12 discharge permits to complete the annual MWPP Audit on the city's sewerage
13 treatment facility,

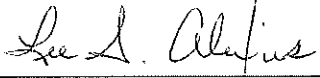
14 **NOW, THEREFORE, BE IT RESOLVED** by the City of Covington in
15 due, regular and legal session convened that the Covington City Council hereby
16 informs Louisiana Department of Environmental Quality that the following actions
17 were taken by the City Council for the City of Covington, Louisiana:

- 18 1. Reviewed the Municipal Water Pollution Prevention Environmental Audit
19 Report which is attached to this resolution.
20
21 2. Set forth the following actions necessary to maintain permit requirements
22 contained in the Louisiana Water Discharge Permit System (LWDPS)
23 number LA0084336.
24
25 a. Continue to provide certified operators for operation and provide 16
26 hours of training per operator over the next year. This training will be
27 conducted through off-site classes and with the assistance of Curtis
28 Environmental Services, Inc.
29
30 b. Maximize aeration to system by maintaining existing equipment,
31 maintaining spare parts inventory and providing extra aeration when
32 required.
33
34 c. Initiate the non-domestic user Ordinance and Permit all identified
35 non-domestic users through modification of existing Sewer
36 Ordinance.

38 d. Complete dredging of Equalization Pond.

40 e. Monitor and review potential sources of metals in the plant effluent.
41
42 f. Complete Plant upgrade and continue upgrade of the collection
43 system to maintain compliance with current annual upgrade program.

45 g. Comply with DEQ lab certification and QA/QC monitoring
46 procedures.
