17 **WHEREAS**, a certain amendment has been suggested to the chapter of the
18 Code addressing fees; and

19 **WHEREAS**, the Covington City Council deems this amendment
20 appropriate to protect the health, safety and welfare of the citizens of Covington;
21 and

22 **WHEREAS**, the City Council has held its public hearing in accordance with
23 law,

24 **NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City
25 of Covington, at its regular session convened, that Chapter 83 Fees, Article IV.
26 Miscellaneous Fees, be amended to include Sec. 83-8. Tree removal permit fees, to
27 read as follows:

28 **Sec. 83-8. Tree removal permit fees.**
29 **The tree removal permit fee shall be \$25.00.**
30

31 **BE IT FURTHER ORDAINED** that if any provision of this ordinance
32 shall be held to be invalid, such invalidity shall not affect other provisions herein
33 which can be given effect without the invalid provision and to this end the
34 provisions of this ordinance are hereby declared to be severable.

35 **WHEREUPON**, this ordinance having been submitted in writing, having
36 been read by title and adopted at a public meeting of the City Council of the City
37 of Covington, State of Louisiana, was then submitted to an official vote as a whole,
38 the vote thereon being as follows:
