6 **AN ORDINANCE OF THE CITY OF COVINGTON**
7 **AMENDING THE FOLLOWING PROVISION OF THE**
8 **COVINGTON CODE OF ORDINANCES: CHAPTER 18**
9 **BUILDINGS AND BUILDING REGULATIONS**

12 **WHEREAS**, a certain amendment has been suggested to the chapter of the
13 Code addressing Buildings and Building Regulations; and

14 **WHEREAS**, the Covington City Council deems this amendment
15 appropriate to protect the health, safety and welfare of the citizens of Covington;
16 and

17 **WHEREAS**, the City Council has held its public hearing in accordance with
18 law,

19 **NOW, THEREFORE**, be it ordained by the City Council of the City of
20 Covington, at its regular session convened, that Chapter 18 Buildings and Building
21 Regulations be amended to read as set forth on Exhibit 1 attached hereto.

22 **BE IT FURTHER ORDAINED** that the amended Chapter 18 Buildings
23 and Building Regulations of the City of Covington Code of Ordinances, once
24 effective, shall replace the current Chapter 18 Buildings and Building Regulations
25 of the City of Covington Code of Ordinances.

26 **BE IT FURTHER ORDAINED** upon the effective date of the amended
27 Chapter 18 Buildings and Building Regulations of the City of Covington Code of
28 Ordinances, the current Chapter 18 Buildings and Building Regulations of the City
29 of Covington Code of Ordinances, shall be repealed.

30 **BE IT FURTHER ORDAINED** that if any provision of this ordinance
31 shall be held to be invalid, such invalidity shall not affect other provisions herein

1 which can be given effect without the invalid provision and to this end the
2 provisions of this ordinance are hereby declared to be severable.

3 **WHEREUPON**, this ordinance having been submitted in writing, having
4 been read by title and adopted at a public meeting of the City Council of the City
5 of Covington, State of Louisiana.

6 **WHEREUPON**, Alexius moved for adoption, ^{as amended} seconded by
7 Blackall and this ordinance was submitted to a vote and resulted in the
8 following:
