5 **AN ORDINANCE OF THE CITY OF COVINGTON**
6 **AUTHORIZING THE EXECUTION OF A CONTRACT**
7 **WITH IESI LA CORPORATION/COASTAL WASTE**
8 **SERVICES**

10 **WHEREAS**, IESI LA Corporation/Coastal Waste Services has made
11 application to the City of Covington for an exclusive contract for a period of five
12 (5) years; and

13 **WHEREAS**, it is deemed in the best interest of the City of Covington to
14 enter into a contract with IESI LA Corporation/Coastal Waste Services
15 ("Company") for garbage collection, transportation and disposal services,

16 **NOW THEREFORE, BE IT ORDAINED** by the City Council of the City
17 of Covington, Louisiana ("Municipality"), in special session duly and legally
18 convened that the City of Covington enter into the contract attached hereto as
19 Exhibit A (Exhibit A available for review at city hall) and that Candace Watkins,
20 Mayor of the City of Covington, be authorized to execute said contract.

21 **BE IT FURTHER ORDAINED**, that all ordinances or parts of ordinances
22 contrary to or in conflict with the provisions of this ordinance be and the same are
23 hereby repealed, and this ordinance shall take effect from and after its
24 promulgation in full and its acceptance in writing by the Company for itself, its
25 successors and assigns.

26 **BE IT FURTHER ORDAINED**, if any provision of this ordinance shall be
27 held to be invalid, such invalidity shall not affect other provisions herein which can
28 be given effect without the invalid provision and to this end the provisions of this
29 ordinance are hereby declared to be severable.

30 This ordinance introduced in regular session on the 7th day of June, 2011.

31 This ordinance having been submitted in writing, having been read by title
32 and adopted at a public meeting of the City Council of the City of Covington, State
33 of Louisiana, was then submitted to an official vote as a whole, the vote thereon
34 being as follows.
