5 **AN ORDINANCE OF THE CITY OF COVINGTON**
 6 **AMENDING THE 2011 BUDGET TO APPROPRIATE**
 7 **FUNDS FOR THE 11TH AVENUE BRIDGE REPAIR,**
 8 **ELECTION AND INAUGURATION EXPENSE AND**
 9 **BOSTON STREET LIGHTING REPAIR.**

 11 **WHEREAS**, the original budget as adopted did not include an
 12 appropriation for repairs to the 11th Avenue Bridge that are now urgently
 13 needed; and

14 **WHEREAS**, an estimate for the Boston Street lighting improvement
 15 has been received; and

16 **WHEREAS**, funds are available in the Annexation Sales Tax Area
 17 Fund for the above mentioned purposes; and

18 **WHEREAS**, the 2011 Budget as adopted underestimated the 2011
 19 election costs and inauguration expenses; and

20 **WHEREAS**, funds are available in the General Fund for this purpose;
 21 and

22 **WHEREAS**, the City Council and Mayor recognize the need to fund
 23 these projects; and

24 **WHEREAS**, it is necessary to amend the 2011 Budget as follows:
