**AN ORDINANCE OF THE CITY OF COVINGTON LEVYING,
IMPOSING AND ADOPTING THE CURRENT MILLAGE

BE IT ORDAINED that the following millages are hereby levied on the

BE IT FURTHER ORDAINED that the proper administrative officials of the Parish of St. Tammany, State of Louisiana, be and they are hereby empowered, authorized, and directed to spread said taxes, as hereinabove set forth, upon the assessment roll of the City of Covington for the year 2017, and to make the collection of the taxes imposed for and on behalf of the taxing authority, according to law, and that the taxes herein levied shall become a permanent lien and privilege on all property subject to taxation as herein set forth, and collection thereof shall be enforceable in the manner provided by law.
