WHEREAS, a tree mitigation special revenue fund was established to allow

for financial mitigation for tree removal by residents and businesses; and

WHEREAS, these funds were intended for use by the City to maintain its

canopy; and

WHEREAS, deposits have been made into that special revenue fund; and

WHEREAS, there is now a necessity to replace dying and/or deteriorating trees in public places as recommended by the Covington Tree Board and Keep Covington Beautiful (KCB); and

**WHEREAS**, the use of these special revenue funds require Council approval as these expenditures were not included in the 2017 Budget; and

WHEREAS, the City Council has held its public hearing in accordance with law.

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Covington, at its regular session convened, that \$10,000.00 from Line Item 27150400-446555 may be used to remove and replace dying trees, as well as, planting additional trees in needed public areas.

BE IT FURTHER ORDAINED that if any provision of this ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

WHEREUPON, this ordinance having been submitted in writing, having been read by title and adopted at a public meeting of the City Council of the City of Covington, State of Louisiana, was then submitted to an official vote as a whole, the vote thereon being as follows:
