7 **A RESOLUTION OF THE COVINGTON CITY COUNCIL**
8 **AUTHORIZING THE USE OF A PORTION OF THE**
9 **UNCONSTRUCTED RIGHT OF WAY ON SOUTH JACKSON**
10 **STREET BETWEEN WEST 13TH AVENUE AND WEST 14TH**
11 **AVENUE AS A DRIVEWAY**

14 **WHEREAS**, South Jackson Street between West 13th Avenue and West 14th
15 Avenue is a dedicated but unopened street; and

16 **WHEREAS**, the City of Covington has received the attached request from
17 Jeff and Heid Shows in which they have requested permission to use a portion of
18 the unconstructed right of way on South Jackson Street between West 13th Avenue
19 and West 14th Avenue and bordering the west side of their property, as a driveway
20 entrance to access their property, which property is more fully described as Lot 1,
21 Square 1307, Division of New Covington, City of Covington, St. Tammany Parish,
22 Louisiana, Municipal address: 327 West 13th Avenue, Covington, Louisiana; and

23 **WHEREAS**, any improvements to the above described portion of the
24 unconstructed street, such as gravel, drainage, grading, removal of trees, etc., must
25 be approved by the Tree Board, City Engineer, Public Works Department, Fire
26 Department and Permits/Code Enforcement Department, before any work is
27 performed; and

28 **WHEREAS**, the City of Covington has no objection to the use of a portion
29 of the unconstructed street as a driveway entrance, said portion measuring
30 approximately 25 feet by 115 feet of the unconstructed right of way on South
31 Jackson Street between West 13th Avenue and West 14th Avenue.

32 **NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the
33 City of Covington in due, regular and legal session convened, that the City Council

hereby grants permission to Jeff and Heid Shows to use approximately 25 feet by
115 feet of the unconstructed right of way on South Jackson Street between West
13th Avenue and West 14th Avenue and bordering the west side of their property, as
a driveway entrance to access their property, with the concurrence and direction
of the Tree Board, City Engineer, Public Works Department, Fire
Department and Permits/Code Enforcement Department.
