INTRODUCTION

CITY OF COVINGTON STATE OF LOUISIANA

ORDINANCE NUMBER 2018-08

AN ORDINANCE OF THE CITY OF COVINGTON SETTING FORTH THE ADJUSTED MILLAGE RATES

BE IT ORDAINED by the City Council for the City of Covington, Parish of St. Tammany, State of Louisiana, in a public meeting held on Tuesday, June 19, 2018, which meeting was conducted in accordance with the Open Meetings Law and the additional requirements of Article VII, Section 23(C) of the Louisiana Constitution and R.S. 47:1705(B), that the following **adjusted** millage rates be and they are hereby levied upon the dollar of the assessed valuation of all property subject to ad valorem taxation within said Parish for the year 2018, for the purpose of raising revenue:

MILLAGE

General Alimony	7.390 mills
Fire Protection Facilities	9.850 mills

BE IT FURTHER ORDAINED that the Assessor of the Parish of St. Tammany, shall extend upon the assessment roll for the year 2018 the taxes herein levied, and the Tax Collector of said Parish shall collect and remit the same to said taxing authority in accordance with law.

BE IT FURTHER ORDAINED that the Covington City Council has held its public hearing in accordance with law.

WHEREUPON, this ordinance having been submitted in writing, having been read by title and adopted at a public meeting of the City Council of the City of Covington, State of Louisiana, was then submitted to an official vote as a whole, the vote thereon being as follows:
