AN ORDINANCE OF THE CITY OF COVINGTON LEVYING AND IMPOSING TAXES ON ALL PROPERTY SUBJECT TO TAXATION IN THE CITY OF COVINGTON, STATE OF LOUISIANA, FOR THE YEAR 2018

BE IT ORDAINED by the City Council for the City of Covington, Parish of St. Tammany, State of Louisiana, in a public meeting held on Tuesday, June 19, 2018, which meeting was conducted in accordance with the Open Meetings Law and the additional requirements of Article VII, Section 23(C) of the Louisiana Constitution and R.S. 47:1705(B), that the taxing district voted to increase the millage rates, but not in excess of the prior year's maximum rates, on all taxable property shown on the official assessment roll for the year 2018, and when collected, the revenues from said taxes shall be used only for the specific purposes for which said taxes have been levied. Said millage rates are:

	<u>Adjusted Rate</u>	<u>2018 Levy</u>
General Alimony	7.390 mills	7.500 mills
Fire Protection Facilities	9.850 mills	10.00 mills
Sewers & Sewer Disposal Works Bonds		3.5 mills

BE IT FURTHER ORDAINED that the Assessor of the Parish of St. Tammany, shall extend upon the assessment roll for the year 2018 the taxes herein levied, and the Tax Collector of said Parish shall collect and remit the same to said taxing authority in accordance with law.

BE IT FURTHER ORDAINED that the Covington City Council has held its public hearing in accordance with law.

1 **WHEREUPON**, this ordinance was read in full, the roll was called on the
2 adoption thereof, and the ordinance was adopted by no less than two-thirds of the total
3 membership of the taxing authority voting in favor as required by Article VII, Section
4 23(C) of the Louisiana Constitution and R.S. 47:1705(B). The votes were:
