ORDINANCE NUMBER 2018- 12

**AN ORDINANCE OF THE CITY OF COVINGTON
DECLARING SURPLUS AND AUTHORIZING
DONATION OF EQUIPMENT**

WHEREAS, a certain piece of equipment, specifically a CET Fire Pump, is no longer used or needed for public safety purposes by the Fire Department; and

WHEREAS, this piece of equipment, namely the CET Fire Pump, should be declared a surplus item; and

WHEREAS, St. Tammany Parish Fire District No. 5 located in Folsom, Louisiana is in need of said piece of equipment, namely the CET Fire Pump; and

WHEREAS, the donation of said surplus piece of public safety equipment is authorized in accordance with Louisiana Revised Statute §38:2319.21; and

WHEREAS, the City Council has held its public hearing in accordance with law.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Covington, at its regular session convened, that the said piece of equipment, namely the CET Fire Pump, be hereby declared a surplus item; and

BE IT FURTHER ORDAINED that the donation of said surplus item, namely the CET Fire Pump, is authorized by state law and the Mayor is hereby authorized to donate such surplus movable property and to sign any and all documents in connection with said donation; and

BE IT FURTHER ORDAINED that if any provision of this ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein

1 which can be given effect without the invalid provision and to this end the
2 provisions of this ordinance are hereby declared to be severable.

3 **WHEREUPON**, this ordinance having been submitted in writing, having
4 been read by title and adopted at a public meeting of the City Council of the City
5 of Covington, State of Louisiana, was then submitted to an official vote as a whole,
6 the vote thereon being as follows:
