**AN ORDINANCE OF THE CITY OF COVINGTON
RECOGNIZING THE MAYOR'S AUTHORITY
TO EXECUTE A LEASE WITH THE
YOUTH SERVICE BUREAU OF ST. TAMMANY, INC.**

WHEREAS, the Youth Service Bureau of St. Tammany, Inc. (YSB) currently owns and operates its services in a building that partially encroaches on the Ox Lot for Square 16; and

WHEREAS, the YSB provides beneficial services to the children of the City of Covington; and

WHEREAS, the YSB currently leases from the City of Covington said portion of ground encroached upon by their building for the total sum of ONE (\$1.00) DOLLAR per year; and

WHEREAS, said lease will expire October 31, 2018; and

WHEREAS, it is the desire of this Mayor, Council and Administration to enter into a new lease with all the same terms and conditions set forth in the current lease for the benefit of the children of the City of Covington; and

WHEREAS, the Covington City Council has held its public hearing in accordance with law.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Covington, at its regular session convened, that the authority of the Mayor of the City of Covington is hereby recognized in order to execute a new lease with the YSB at the same terms and conditions as previous leases.

1 **BE IT FURTHER ORDAINED** that if any provision of this ordinance
2 shall be held to be invalid, such invalidity shall not affect other provisions herein
3 which can be given effect without the invalid provision and to this end the
4 provisions of this ordinance are hereby declared to be severable.

5 **WHEREUPON**, this ordinance having been submitted in writing, having
6 been read by title and adopted at a public meeting of the City Council of the City
7 of Covington, State of Louisiana, was then submitted to an official vote as a whole,
8 the vote thereon being as follows:
