### ORDINANCE NUMBER 2018- 31

#### AN ORDINANCE OF THE CITY OF COVINGTON DECLARING SURPLUS AND AUTHORIZING DONATION OF EQUIPMENT

13       **WHEREAS**, two (2) certain pieces of equipment, specifically a white 5' x  
14 10' cargo trailer on tongue 7427 and a red 5' x 10' cargo trailer on tongue 9898,  
15 are no longer used or needed for public safety purposes by the Fire Department;  
16 and

17       **WHEREAS**, these pieces of equipment, namely the white 5' x 10' cargo  
18 trailer on tongue 7427 and the red 5' x 10' cargo trailer on tongue 9898, should be  
19 declared surplus items; and

20       **WHEREAS**, St. Tammany Parish Fire District No. 13 located in Goodbee,  
21 Louisiana is in need of said pieces of equipment, namely the white 5' x 10' cargo  
22 trailer on tongue 7427 and the red 5' x 10' cargo trailer on tongue 9898; and

23       **WHEREAS**, the donation of said surplus pieces of public safety equipment  
24 is authorized in accordance with Louisiana Revised Statute Sec. 38:2319.21; and

25       **WHEREAS**, the City Council has held its public hearing in accordance with  
26 law.

27       **NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City  
28 of Covington, at its regular session convened, that the said pieces of equipment,  
29 namely the white 5' x 10' cargo trailer on tongue 7427 and the red 5' x 10' cargo  
30 trailer on tongue 9898, be hereby declared surplus items; and

31       **BE IT FURTHER ORDAINED** that the donation of said surplus items,  
32 namely the white 5' x 10' cargo trailer on tongue 7427 and the red 5' x 10' cargo  
33 trailer on tongue 9898, is authorized by state law and the Mayor is hereby  
34 authorized to donate such surplus movable property and to sign any and all  
35 documents in connection with said donation; and

36       **BE IT FURTHER ORDAINED** that if any provision of this ordinance  
37 shall be held to be invalid, such invalidity shall not affect other provisions herein
