WHEREAS, a certain amendment has been suggested to add language to the section of the Code addressing the usage of tree mitigation funds; and

WHEREAS, the Covington City Council deems this amendment appropriate to more adequately and specifically express the intended usage of tree mitigation funds; and

WHEREAS, the City Council has held its public hearing in accordance with law.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Covington, at its regular session convened, that Appendix B—Comprehensive Zoning Ordinance of 2010, Part 4. General Provisions, Section 4.2. Landscaping and Tree Preservation, Section 4.207. Tree mitigation, enforcement and violations, shall be amended to read as follows:

30 4. Payment in lieu of planting.

(b) Payments will be made to a mitigation fund to be used for approved tree planting and landscaping improvements, as well as, preservation and maintenance of existing trees along public streets, in public parks and public spaces within the city.

BE IT FURTHER ORDAINED that all other sections of Appendix B—Comprehensive Zoning Ordinance of 2010 shall remain the same and in full force.

BE IT FURTHER ORDAINED that if any provision of this ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.
