**AN ORDINANCE OF THE CITY OF COVINGTON
AMENDING THE COVINGTON CODE OF ORDINANCES:
CHAPTER 94 TRAFFIC AND VEHICLES,
ARTICLE I. IN GENERAL, TO ADD SECTION 94-7.
MAXIMUM SPEED LIMIT**

WHEREAS, it has been determined that a definitive maximum speed limit be established for the City of Covington; and

WHEREAS, the Covington City Council deems such a maximum speed limit is appropriate to protect the health, safety and welfare of the citizens of Covington; and

WHEREAS, the City Council has held its public hearing in accordance with law.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Covington, at its regular session convened, that Chapter 94 Traffic and Vehicles, Article I. In General, shall be amended to add Section 94-7., to read as follows:

Sec. 94-7. Maximum speed limit.
No person shall operate a vehicle on any municipal street or avenue of this city in excess of twenty-five (25) miles per hour, unless a lower or higher maximum speed is posted on the street or avenue. In such case, the posted maximum speed shall control.

BE IT FURTHER ORDAINED that if any provision of this ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

WHEREUPON, this ordinance having been submitted in writing, having been read by title and adopted at a public meeting of the City Council of the City of
