**AN ORDINANCE OF THE CITY OF COVINGTON
AMENDING THE 2020 BUDGET FOR THE
CITY'S NEW WEBSITE**

WHEREAS, the City of Covington adopted a 2020 Operating and Capital Budget in November 2019; and

WHEREAS, the funds allocated in the 2020 Budget are not sufficient for the actual cost of the new website; and

WHEREAS, it is necessary to amend the 2020 Budget as follows:

Increase to 01110030-446530	\$22,000.00
Decrease to General Fund Balance	\$22,000.00

WHEREAS, the Covington City Council has held its public hearing in accordance with law.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Covington, Louisiana, at its regular session convened, that the 2020 Budget shall be amended as set out above.
