**AN ORDINANCE OF THE CITY OF COVINGTON
AUTHORIZING THE MAYOR TO EXECUTE A LEASE
WITH BABY LEE LLC.**

WHEREAS, the Covington City Council has held all public hearings required of it in accordance with law; and

WHEREAS, the Covington City Council deems that the execution of this lease is in the best interest of the health, safety and welfare of the citizens of Covington.
