7 **A RESOLUTION OF THE COVINGTON CITY COUNCIL**

11 **WHEREAS**, on September 16, 2014 by Resolution No. 2014-22, the
12 Covington City Council granted permission to Mr. and Mrs. Randy Meyer to use
13 approximately 20 feet by 120 feet on the unconstructed East 8th Avenue, connected
14 to South Louisiana Street, as a driveway entrance to access their property, with the
15 concurrence and direction of the Tree Board, City Engineer, Code Enforcement
16 Officer, Covington Fire Department and Permits Department; and

17 **WHEREAS**, it has been discovered that Mr. and Mrs. Meyer are requesting
18 to use approximately 20 feet by 240 feet on the unconstructed East 8th Avenue,
19 connected to South Louisiana Street, as a driveway entrance to access their
20 property; and

21 **WHEREAS**, the City Council for the City of Covington hereby amends
22 Resolution No. 2014-22 as follows:

23 **BE IT RESOLVED** that the City Council of the City of Covington hereby
24 grants permission to Mr. and Mrs. Randy Meyer to use approximately 20 feet by
25 240 feet on the unconstructed East 8th Avenue, connected to South Louisiana
26 Street, as a driveway entrance to access their property, **with the concurrence and**
27 **direction of the Tree Board, City Engineer, Code Enforcement Officer,**
28 **Covington Fire Department and Permits Department.**

29 **NOW, THEREFORE, BE IT RESOLVED** that the City Council for the
30 City of Covington, at a meeting duly convened, hereby grants permission to Mr.
31 and Mrs. Randy Meyer to use approximately 20 feet by 240 feet on the

unconstructed East 8th Avenue, connected to South Louisiana Street, as a driveway
entrance to access their property, with the concurrence and direction of the Tree
Board, City Engineer, Code Enforcement Officer, Covington Fire Department
and Permits Department.
