WHEREAS, the City of Covington adopted a 2014 Operating Budget in November 2013; and

WHEREAS, \$534,536 is budgeted to be transferred into the General Fund from the 1982 Sales Tax Fund for Recreation and only \$502,066 is budgeted as expenditures for recreation; and

WHEREAS, the commitment of \$30,000 in additional funds is needed for the Peter Atkins Park Basketball Court Roof Project which will complement funding already committed by "Hoops for Kids" and the St. Tammany Parish Government CDBG Program; and

WHEREAS, it is necessary to amend the 2014 Budget as follows:

Increase to Parks, Playgrounds, Fields 01160535-465000	\$30,000
Decrease to General Fund - Fund Balance	\$30,000

WHEREAS, the City Council has held its public hearing in accordance with law,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Covington, Louisiana, in regular session convened, that the 2014 Budget be amended as set out above.


WHEREUPON, this ordinance having been submitted in writing, having been read by title and adopted at a public meeting of the City Council of the City


