**AN ORDINANCE OF THE CITY OF COVINGTON
AMENDING THE 2016 OPERATING BUDGET
FOR MUNIS UBCIS**

15 **WHEREAS**, the City of Covington adopted a 2016 Operating Budget in
16 November of 2015; and

17 **WHEREAS**, Munis is no longer updating or enhancing the features of the
18 Classic Utility Billing, which is what the City utilizes now; and

19 **WHEREAS**, getting support for the Classic Utility Billing is becoming a
20 challenge; and

21 **WHEREAS**, Munis UBCIS provides more functionality than Classic Utility
22 Billing; and

23 **WHEREAS**, it is necessary for the City to move to Munis UBCIS to utilize
24 this increased functionality and to get adequate support; and

25 **WHEREAS**, it is necessary to amend the 2016 Operating Budget as
26 follows:

27	Increase to Water Admin Training 50310610-448500	\$30,950
28	Decrease to Utility Fund Unrestricted Net Position	\$30,950

30 **WHEREAS**, the Covington City Council has held its public hearing in
31 accordance with law.

32 **NOW, THEREFORE, BE IT ORDAINED** by the City Council of the
33 City of Covington, Louisiana, at its regular session convened, that the 2016
34 Operating Budget shall be amended as set out above.
