16       **WHEREAS**, the City of Covington adopted a 2016 Capital Budget in  
17 November 2015; and

18       **WHEREAS**, it has come to our attention that the roof on the Police  
19 Department Building is in need of replacement; and

20       **WHEREAS**, funding was not budgeted for the replacement of the roof; and

21       **WHEREAS**, funding was budgeted for the equipping of new police  
22 vehicles; and

23       **WHEREAS**, the vehicles have been ordered but will not be received until  
24 around August of 2016; and

25       **WHEREAS**, it is necessary to utilize the funds budgeted for the equipping  
26 of the police vehicles to replace the roof; and

27       **WHEREAS**, these vehicles will need to be equipped once they are received;  
28 and

29       **WHEREAS**, it is necessary to amend the 2016 Capital Budget as follows:

30	Increase to Police Vehicles 21130200-462500	\$56,000
31	Decrease to 1982 Sales Tax Fund Balance	\$56,000
