### ORDINANCE NUMBER 2016-21

AN ORDINANCE OF THE CITY OF COVINGTON LEVYING,  
IMPOSING AND ADOPTING THE ADJUSTED MAXIMUM  
MILLAGE AFTER REAPPRAISAL/REASSESSMENT ON ALL  
PROPERTY SUBJECT TO TAXATION IN THE CITY OF  
COVINGTON, STATE OF LOUISIANA, FOR THE YEAR 2016

BE IT ORDAINED that the following millages are hereby levied on the  
2016 tax roll on all property subject to taxation by the:

BE IT FURTHER ORDAINED that the proper administrative officials of  
the Parish of St. Tammany, State of Louisiana, be and they are hereby empowered,  
authorized, and directed to spread said taxes, as hereinabove set forth, upon the  
assessment roll of the City of Covington for the year 2016, and to make the  
collection of the taxes imposed for and on behalf of the taxing authority, according  
to law, and that the taxes herein levied shall become a permanent lien and privilege  
on all property subject to taxation as herein set forth, and collection thereof shall be  
enforceable in the manner provided by law.

WHEREUPON, this ordinance having been submitted in writing, having  
been read by title and adopted at a public meeting of the City Council of the City


1 of Covington, State of Louisiana, at which meeting a quorum was present and


