12 **WHEREAS**, it has been determined that the property described in attached
13 Exhibits A and B is no longer needed for the public purposes of the City of
14 Covington; and

15 **WHEREAS**, it is the desire of the City Council for the City of Covington to
16 comply with Louisiana state law regarding the disposition of surplus property,

17 **NOW, THEREFORE, BE IT ORDAINED** by the City Council for the
18 City of Covington, Louisiana, in regular session convened, that the movable
19 property described in attached Exhibits A and B is hereby declared not needed for
20 public use and therefore surplus; and

21 **BE IT FURTHER ORDAINED** that said surplus property described in
22 attached Exhibits A and B be disposed of pursuant to Louisiana Revised Statute
23 49-125 and the Director of Administration is hereby authorized to sell such surplus
24 movable property at public auction; and

25 **BE IT FURTHER ORDAINED** that if any provision of this ordinance
26 shall be held to be invalid, such invalidity shall not affect other provisions herein
27 which can be given effect without the invalid provision and to this end the
28 provisions of this ordinance are hereby declared to be severable.

29 **WHEREUPON**, this ordinance having been submitted in writing, having
30 been read by title and adopted at a public meeting of the City Council of the City
31 of Covington, State of Louisiana, was then submitted to an official vote as a whole,
32 the vote thereon being as follows:




