**AN ORDINANCE OF THE CITY OF COVINGTON
 AMENDING THE 2016 OPERATING BUDGET FOR PLANS
 AND SPECS FOR THE OLD FIRE STATION ON NORTH
 THEARD STREET**

WHEREAS, the City of Covington adopted a 2016 Budget in November 2015; and

WHEREAS, an application was submitted for a grant for plans and specs for the old fire station on North Theard Street; and

WHEREAS, \$82,000 was budgeted in the grant fund for this project including anticipated grant funding of \$5,000 with City match of \$77,000; and

WHEREAS, grant funding was not approved for this project; and

WHEREAS, the Mayor would like to see this project move forward; and

WHEREAS, it is necessary to move this project from the grant fund to the 1982 sales tax fund; and

WHEREAS, it is necessary to amend the 2016 Budget as follows:

1982 SALES TAX FUND

Increase to Admin -Building 21110030-463500	\$82,000
Decrease to T/O to grant fund 21210900-492525	\$77,000
Decrease to 1982 S/T fund balance	\$ 5,000

GRANT FUND

Decrease to Cultural Arts Building 25120102-463500	\$82,000
Decrease to T/I from General Fund 25000009-392021	\$77,000
Decrease to Grant Revenue 25000020-330050	\$ 5,000
