**AN ORDINANCE OF THE CITY OF COVINGTON
AMENDING THE 2016 OPERATING BUDGET FOR RIFLE-
PROOF VESTS FOR COVINGTON POLICE OFFICERS**

WHEREAS, the City of Covington adopted a 2016 Operating Budget in
November 2015; and

WHEREAS, police officers all across the country have come under attack;
and

WHEREAS, for the safety of the police officers who so valiantly protect the
people of Covington; and

WHEREAS, the Mayor and Police Chief felt it was necessary to protect our
officers by providing them with rifle-proof vests; and

WHEREAS, funding was not budgeted for these rifle-proof vests; and

WHEREAS, it is necessary to amend the 2016 Operating Budget as
follows:

Increase to Police Uniforms 01130200-446060	\$33,000
Decrease to General Fund-Fund Balance	\$33,000

WHEREAS, the Covington City Council has held its public hearing in
accordance with law.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the
City of Covington, Louisiana, at its regular session convened, that the 2016
Operating Budget be amended as set out above.


