**AN ORDINANCE OF THE CITY OF COVINGTON
 AMENDING THE 2016 OPERATING BUDGET FOR
 RECREATION SALARIES**

WHEREAS, the City of Covington adopted a 2016 Operating Budget in November 2015; and

WHEREAS, the Mayor recently appointed a Recreation Director filling the vacant position; and

WHEREAS, funds were not budgeted in the 2016 Operating Budget for this position; and

WHEREAS, it is necessary to increase the budgets for the salary and benefits for this position for the remainder of this year; and

WHEREAS, additional funds are needed for part time recreation salaries; and

WHEREAS, it is necessary to amend the 2016 Operating Budget as follows:
