**AN ORDINANCE OF THE CITY OF COVINGTON
AMENDING THE 2013 BUDGET FOR GRANTS AND
UNANTICIPATED EXPENDITURES**

WHEREAS, the City of Covington adopted a 2013 Operating and Capital Budget in November 2012; and
