22 facilities and activities for the children who live in and near the City of Covington,

24 City of Covington, at a meeting duly convened, hereby confirms the appointments
25 of Baldwin Brown and Scott Salter to the St. Tammany Recreation District #10
26 Board of Commissioners for a term commencing on this date and ending on July 1,
27 2015,
