A RESOLUTION OF THE COVINGTON CITY COUNCIL
RECOGNIZING CHARLIE CRAWFORD AND RONNIE TYRNEY
FOR THEIR CONTRIBUTIONS TO HADDEN HALL

WHEREAS, Hadden Hall is a structure built in the 1930s and the former home of Robert H. Burns American Legion Post 16; and

WHEREAS, Hadden Hall is privately owned and leased to the Council on Aging St. Tammany (COAST) and is used as the Covington Senior Center. Also, the facility is used for the monthly Friends of the Library book fair; and

WHEREAS, the flagpole in front of Hadden Hall was damaged as a result of Hurricane Katrina and some other repairs were needed to the sign and chain fence; and

WHEREAS, since COAST was not able to fund the repairs due to budget constraints, Charlie Crawford contacted his friend, Ronnie Tyrney, owner of R&R Tree Service, for help with the repairs; and

WHEREAS, Charlie Crawford is a river pilot and submitted a grant request to the Crescent River Pilots Foundation and received a \$2,500 grant award for the repairs; and

WHEREAS, over the course of several weeks, Charlie Crawford and Ronnie Tyrney performed the repairs and in early December, all of the repairs were completed; and

WHEREAS, the Covington City Council would like to recognize and commend Charlie Crawford and Ronnie Tyrney for their dedication and devotion to this project,

NOW, THEREFORE, BE IT RESOLVED that the City Council for the City of Covington, at a meeting duly convened, hereby recognizes and commends Charlie Crawford and Ronnie Tyrney for volunteering and performing the repairs and improvements to Hadden Hall.
