Joseph Bobrowski in which they have requested permission to use the

unconstructed West 7th Avenue between South Jefferson Avenue and South

Madison Street as a driveway entrance to access their property, said property bears

the municipal address of 110 West 7th Avenue; and

WHEREAS, any improvements to the above described portion of the

unconstructed street, such as gravel, drainage, grading, removal of trees, etc., must

be approved by the Tree Board, City Engineer, Code Enforcement Officer and

Permits Department, before any work is performed; and

WHEREAS, the City of Covington has no objection to the use of the

unconstructed street as a driveway entrance,

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the

City of Covington in due, regular and legal session convened, that the City Council

hereby grants permission to Mr. and Mrs. Joseph Bobrowski to use the

unconstructed West 7th Avenue between South Jefferson Avenue and South

Madison Street, as a driveway entrance to access their property, with the

concurrence and direction of the Tree Board, City Engineer, Code

Enforcement Officer and Permits Department.
