A RESOLUTION OF THE COVINGTON CITY COUNCIL
AUTHORIZING THE MAYOR TO SIGN A COOPERATIVE
ENDEAVOR AGREEMENT WITH ST. TAMMANY PARISH
GOVERNMENT IN CONNECTION WITH THE DISPOSITION
METHOD FOR PROCEEDS OF ADJUDICATED PROPERTY SALES

WHEREAS, there are properties located within the city limits of the City of Covington which have been adjudicated to the Parish of St. Tammany for unpaid ad valorem taxes; and

WHEREAS, according to La. R.S. 33:1321-1337, the City of Covington desires to contract with St. Tammany Parish Government in connection with the disposition method for any proceeds which may be realized from the sale of the adjudicated properties which are located within the city limits of the City of Covington; and

WHEREAS, in the event that any of the adjudicated properties located within the city limits of the City of Covington are sold, St. Tammany Parish Government shall disburse the proceeds as set forth in the attached Cooperative Endeavor Agreement; and

WHEREAS, it is the desire and intent of the Mayor and administration of the City of Covington to enter into the attached Cooperative Endeavor Agreement for the sharing of adjudicated property proceeds.

NOW, THEREFORE, BE IT RESOLVED that the City Council for the City of Covington, at a meeting duly convened, hereby authorizes the Mayor to execute the attached Cooperative Endeavor Agreement pertaining to adjudicated property proceeds sharing between the City of Covington and St. Tammany Parish Government.
