12 **WHEREAS**, certain amendments and additions have been suggested to the
13 sections of the Code addressing Water and Sewerage rates; and

14 **WHEREAS**, the Covington City Council deems these amendments
15 appropriate to protect the health, safety and welfare of the citizens of Covington;
16 and

17 **WHEREAS**, the City Council has held its public hearing in accordance with
18 law,

19 **NOW, THEREFORE**, be it ordained by the City Council of the City of
20 Covington, at its regular session convened, that Sec. 98-122. Water rates and Sec.
21 98-123. Sewerage rates, be amended to read as follows:

22 **Sec. 98-122. Water rates.**

23 (e) The rates charged to mixed users shall be the higher of the two applicable
24 user rates with the exception that existing multi-unit structures on a single compound
25 meter will be billed at the lower rate per unit.

27 **Sec. 98-123. Sewerage rates.**

28 (e) The rates charged to mixed users shall be the higher of the two applicable
29 user rates with the exception that existing multi-unit structures on a single compound
30 meter will be billed at the lower rate per unit.

33 **BE IT FURTHER ORDAINED** that all other sections of Chapter 98,
34 Utilities, remain the same and in full force.

35 **BE IT FURTHER ORDAINED** that if any provision of this ordinance
36 shall be held to be invalid, such invalidity shall not affect other provisions herein

1 which can be given effect without the invalid provision and to this end the
2 provisions of this ordinance are hereby declared to be severable.

3 WHEREUPON, this ordinance having been submitted in writing, having
4 been read by title and adopted at a public meeting of the City Council of the City
5 of Covington, State of Louisiana.
