6 SETTING FORTH THE ADJUSTED MILLAGE RATES

8 **BE IT ORDAINED** by the City Council for the City of Covington,
9 Parish of St. Tammany, State of Louisiana, in a public meeting held on Tuesday,
10 July 17, 2012, which meeting was conducted in accordance with the Open
11 Meetings Law and the additional requirements of Article VII, Section 23(C) of
12 the Louisiana Constitution and R.S. 47:1705(B), that the following **adjusted**
13 millage rate(s) be and they are hereby levied upon the dollar of the assessed
14 valuation of all property subject to ad valorem taxation within said Parish for the
15 year 2012, for the purpose of raising revenue:

23 **BE IT FURTHER ORDAINED** that the Assessor of the Parish of St.
24 Tammany, shall extend upon the assessment roll for the year 2012 the taxes
25 herein levied, and the Tax Collector of said Parish shall collect and remit the
26 same to said taxing authority in accordance with law.

28 been read by title and adopted at a public meeting of the City Council of the City
29 of Covington, State of Louisiana, was then submitted to an official vote as a
30 whole, the vote thereon being as follows:
