**AN ORDINANCE OF THE CITY OF COVINGTON
AMENDING THE 2015 BUDGET FOR ADDITIONAL FUNDS
FOR RESCUE/SERVICE COMPANY TRUCK**

WHEREAS, the City of Covington adopted a 2015 Operating and Capital Budget in November 2014; and

WHEREAS, \$128,000 was budgeted in the Capital Budget for a new rescue/service company truck; and

WHEREAS, it has been determined that the cost of the rescue/service company truck will be \$159,000; and

WHEREAS, the Fire Department needs an additional \$31,000 to purchase the rescue/service company truck; and

WHEREAS, it is necessary to amend the 2015 Capital Budget as follows:

Increase to 21140300-462500 Vehicles	\$31,000
Decrease to 1982 Sales Tax Fund Balance	\$31,000

WHEREAS, the Covington City Council has held its public hearing in accordance with law,


NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Covington, Louisiana, at its regular session convened, that the 2015 Budget be amended as set out above.

WHEREUPON, this ordinance having been submitted in writing, having been read by title and adopted at a public meeting of the City Council of the City of Covington, State of Louisiana, was then submitted to an official vote as a whole, the vote thereon being as follows:
